Fell End Broadband

It was reported that the first phase of installation of ducting is complete and awaiting BT engineers to insert the fibre cables.

Children's Play Areas

The Annual Inspection Reports revealed a few very minor defects which will be resolved shortly. It was noted that the Scandal Beck area was waterlogged. Drainage schemes to solve this problem are being investigated.

Ravenstonedale Community & Heritage Centre

The High Chapel graveyard has been tidied by a Community Payback team at no charge to the parish.

The sum of £1,100.00 was paid to the Parish Council by the Management Committee as a contribution towards the cost of heating oil, electricity and insurance for the current year.

Eden District Council – Open Meeting Newbiggin-on Lune

Public Participation

Kyle Blue, Chairman of Orton Parish Council, reported that a planning application has been made to erect a 67 metre high wind turbine in Orton parish. Both Orton and Tebay parish councils have recommended that this application be refused on the grounds of the scale of this unacceptable intrusion into an area of open countryside. It is feared also that, if granted, this would lead to a proliferation of applications along the ridge to Ash Fell.

Cllr. Blue suggested that members of Ravenstonedale PC may wish to make their own representations to Eden District Council Planning Committee.
